
Muckhart LPP Information Notice Period Summary Report

 - Muckhart and Glendevon Amenity Society responses highlighted in pale orange






- 1. Improved availability and awareness of provision suppliers is beneficial for all. Opportunity to start small and explore options for more permanent offering.

- 3. Even villages with a shop have limited use because of price e.g. Crook of Devon.
- 4. Not needed in a village the size of Muckhart and we live less than 20 mins from a shop.
- 5. Pop up in small hall a great idea space and washing facilities important. Is telephone exchange big enough for a shop?
- 6. It would challenge other businesses. Can't see a need
- 7. Current limitation of local community transport and no available public transport
- 8. We already have a community shop so we don't need another. The community should support Monas and mobile food and deliveries currently on offer.
- 9. Good idea in principal but is a long way off. In the short term we could encourage the use of Supermarket deliveries and encourage mobile shops like the Fish-vans that visit the area
- 10. Neutral on this, not sure it's needed, but one point made to me by people who run/have run community shops is the social cohesion it brings to the community for some people. If we do set up a village shop I think we should try to include a cafe!!





- 5. For Natural Heritage Assets Designation is good but should be supported by actual proposals for management if these are to be maintained and enhanced.
- 6. Good idea for listing perceived assets as it focuses resident's views on what is available for future improvement; the Commonty is a long shot
- 7. I don't agree everything on the list merits this. For example, while Mona's cafe is an asset to the village, it isn't of historical importance like the pub and the golf.
- 8. Improving and developing local assets and infrastructure is essential for our community
- 9. Fine, I am sure you have identified the important ones in the plan.






- 1. I would not support new dwellings being restricted to 1.5 storey, not consistent with existing. I would not welcome single dwellings and small-scale clusters. I would not be automatically favourable to support homes outside the settlement boundary
- 2. Strongly support this proposal
- 3. Fully support preventing coalescence between Yetts and Pool
- 4. Muckhart and Clackmannanshire Councils opposed Meadowside development but this was over ruled so local policies were invalid.
- 5. Limit of 3 bedrooms and 5 houses is absurd. Stinks of trying to control family size. No allowance for elderly family. Lose economies of scale.
- 6. Wording of proposal needs to be stronger. We need to oppose another Meadowside Crescent.
- 7. A few infill houses would be fine but no more out of character housing estates.
- 8. Last paragraph of this in section 5 (page 70) says it all
- 9. Type of housing should be appropriate to rural setting.
- 10. I feel we should encourage additional housing only in selected gap sites; the sewage works must be working at over capacity especially in heavy rainfall which will surely limit any more housing until a lot of money spent on infrastructure
- 11. Agree with limit on new builds, but consideration should be given to renovation / repurpose of old buildings

- 3. Fully support applications in the MCA designed to secure cost-efficient heating and energy efficient homes
- 4. Support PVC windows but not a civic space.
- 5. There is already changes to houses along this road but changes were made many years ago. I do think double glazing should be allowed. The Main Street is very attractive and should be preserved
- 6. Net zero and PVC are incompatible.
- 7. Support heat conservation measures in conservation areas. Do not support redevelopment of area around hall.
- 8. Support installation of PVC windows. Do not support a civic space east of the Hall but would support one at access to new housing development.
- 9. Energy saving upgrades should be available to all in conservation area. Civic space desirable but not yet essential.
- 10. Supportive as wish to balance need to improve renewable energy solutions for homes in the conservation area with the maintenance of the character of the village. Less convinced about the desirability of a civic space but open to community views.
- 11. NEUTRAL While important to protect the Conservation nature of the village, some flexibility needed so houses are not disadvantaged in terms of renewable measures. Less supportive of a civic space study resource intensive and potential neg and pos. impacts.

- 1. A route to Dollar Essential to provide a safe route for walking, cycling and wheeling and reduce reliance on the car, especially given our lack of public transport. The whole route to be developed not just path improvements.
- 2. Priority item, make active travel appealing and more people walking and cycling safely.
- 3. Not sure in this financial climate we can do too much
- 4. High priority
- 5. Active travel should be the privilege of all not just those fit enough to cope with the existing terrain. This is a proposal that will take a lot of time effort and money to achieve
- 6. It would be great if this could be expanded to cover Yetts to Waterworks.
- 7. Definitely support, but please keep in mind those residents living outside of Muckhart we don't even have a path to walk into Muckhart some of the way. Public transport reaching those more isolated homes and consideration for footpath into Muckhart
- 8. Regular public transport liaising with other routes is essential to encourage its use. Good safe cycle paths also essential
- 9. Whenever new roads constructed/existing roads upgraded, provision should be made for pedestrians & cyclists. A safe route following the A91 to Milnathort for both would allow travel connection to sports, shopping & sports facilities.

- 16. SUPPORT This would provide significant community benefit if achievable.

Optional Final Comments

- Overall I think this is a really good plan and covers some important areas that are based on the needs of the community. Personally, I really support and appreciate the focus on nature and climate and will be keen to get involved to support some of the initiatives. I would like to highlight the importance of including issues that are important for people living on the edges of the community, as it seems more focused towards the village / Pool of Muckhart. I appreciate this is where the main population is, but inclusion of those on the edge is also very important, especially in such an isolated area. I would also like to highlight one item which is included in the Community Action Plan but not featured in the 12 projects. That is road safety (MA iii, p. 56). "There is also a need to consider surrounding areas where road safety is of concern such as the road between Yetts of Muckhart and Glendevon." I live in this area and this is an urgent safety risk. There have been a number of serious accidents in the last few months and even if it is not covered in the 12 projects, it needs urgent prioritisation to put safety measures in place before someone loses their life.
- 2. supportive of all projects too
- 3. Thanks so much for all the work to pull this together. Lots of fantastic ideas and projects. I particularly love the climate (home energy and renewables) and nature priorities as well as the shop and ideas for repair cafe, etc. that will be great for sustainability but also connecting the community more. A major concern I have above all else at the moment is road safety. The road from Glendevon into Yetts of Muckhart is very dangerous. Speeding is a huge issue and given the danger of this road and the number of accidents I am disappointed to not see road safety as a top priority. In the last 18 months there has been at least six collisions on the small windy stretch and at least four near misses of people very nearly being hit by cars (including recently a Scottish Water worker). We are incredibly lucky there hasn't been serious injuries or a fatality and feel this is an urgent priority. All residents I've spoken to have agreed and many of the delivery drivers say this is the worst road they have to deliver on. There has been quite a number of complaints to the Clacks Council but no follow up.
- 4. All of the MA projects, in particular MAii, fully support Muckhart residents and are key to our future
- 5. Could we please upgrade the playpark with swings, seesaw etc. Thanks
- 6. We greatly appreciate the time and effort by the members of the community council in producing this document and members of the public who engaged with workshops. The council have been ambitious in the number and scope of the proposals and projects, perhaps overly so, given the size of the village. The council will need community involvement and that may be challenging, given all the other commitments that villagers have. However, it is appreciated that the purpose of the survey is to whittle the number of proposals down, so they will be manageable long term. We would have appreciated a separate survey on the projects as we feel there are too many. We support play park upgrade and additional car parking at the church. We do not support a community shop, business units within Muckhart village or redesigned civic space as they will change the culture and character of the village. We are neutral about the other projects. Some comments on the document itself it was not an easy or engaging read and the document was long and difficult to navigate especially when trying to answer the survey questions and cross reference back to it. Also, we could not re-read our survey responses easily and had to use arrow key to see whole response.

- 7. So much work has been done on driving through village well established A road. Too many houses with on-road parking. Better connections for bus, cycling and walking needed.
- 8. The reason most people choose to live in Muckhart is because they feel safe and it's a warm and friendly place to live despite the negatives of transport etc many people find it has more than enough to offer them.
- 9. Should not need to rely on volunteer bus drivers and need proper service Desperately need more proper parking space. Also need yellow lines by hall as when cars parked on the road larger vehicles including emergency vehicles do not have enough room to access Golf View/School Road Public space do ok with church and hall. Cycle ways to Dollar, Yetts and beyond great idea. Business units one for the future. Commonty also for future but will be interesting.
- 10. A Development Trust would need to have agreed objectives and for project management.
- 11. Too much clutter in the village but we need parking spaces along street. Try speed indicator signs to control speed
- 12. Include a resilience hub at the hall, including off-grid energy so locals can warm up, charge phones and have a hot drink in case of severe weather and loss of electricity.
- 13. All good worthwhile projects. 1. Starting with the Development trust which is the way forward. 2. The Additional parking is the next must do. 3. Community Transport next. I would probably rank the remainder as being of equal rank with the Commonty and Redesigned civic space as nice to have long shots.
- 14. Support all projects.
- 15. DTi: A Trust would be beneficial in terms of charitable status to secure potentially significant funding for projects. However, I am dubious of anything termed a "quick win project". Proper due diligence, governance and robust project plans for any initiative is required regardless of scale, prior to implementing any change or new idea case in point being the purchase of a community bus without a thorough cost benefit analysis and risk assessment. Fii: This would be a fantastic asset. However, there is very little mention currently in the plan regarding Environmental Health considerations, which would be significant and is particularly challenging in a volunteer-led initiative. Accepting food deliveries and storing food items (even ambient), requires a robust food management system, with Council oversight. "Compliance with legislation/hygiene" barely scratches the surface of what is a huge amount of record keeping and monitoring. Much more consideration required.
- 16. I feel a regular bus service between Kinross and Stirling should be reinstated and hope that the council would see the value of this In general terms I feel this survey was too long and complicated Perhaps something simpler would attract a better response.
- 17. Feel a Development Trust is key to enable the projects to be realised.
- 18. Community transport is essential to the village and residents. Supportive of additional car parking but would like a worthwhile consultation about all options for parking. Support all projects apart from redesigned civic space and community shop.
- 19. The Dollar to Muckhart cycle route is much needed. Flying fox for park, pump track/skatepark in park, gravel used paths. Open a small shop. Have a monthly/weekly newspaper with puzzles and a comic. Tennis court.
- 20. The creation of a Community Development Trust first is an absolute necessity. A 'CDT' would be able to take a lead on developing 'Community Action Plan' projects, attract funding, to speed the projects along and decide 'community action plan' priorities. Secondly, introduction of a community shop once or twice a week, as a pop-up shop at

- the Hall or Church, this could perhaps also include the promotion of 'the reuse/upcycling initiatives?
- 21. The plan has no mention at all of digital connectivity. We have an exchange only copper wire internet connection with only 10mps. Mobile phone connection is only 4G. Are there plans in the next decade for any improvement?
- 22. The plan says all the right things, however regarding active travel routes, and moving forward with community transport project, I am not confident that this is the best way forward I believe it is essential to keep the pressure on local authorities to run a proper public transport system, serving the needs of all of their communities fairly, especially those on main traffic routes. Once we go down the community led transport project, I believe the local authority will not feel they have an obligation to provide a public service in our community
 - Would be great to have hedges and ferns cut back along Maudie's Lane and reinstate dog poo bin there. It would be amazing if we can do a community buyout of the Church glebe field and allow children to play there, also to ensure the Glebe field is not purchased by a developer and built upon. A tennis court would be a great addition to the village, perhaps next to the existing playpark. Additional traffic calming measures would really help us as many drivers ignore the 20 mph limit. Fixing the road drain in Kirkhill, to prevent an enormous puddle forming. Additional double yellow lines where Kirkhill meets the hight street would stop parking there, which is dangerous.
- 23. Impressive piece of work, well done to everyone who was instrumental in driving the project to produce a 'Bible for Muckhart'. Very comprehensive, broad and in-depth....and, at times, rather overwhelming in terms of the work to be done going forwards. I just wonder whether a small population such as ours has sufficient numbers of people with the energy and drive to make the vision a reality. Deciding the priorities, especially in these straightened times of scarce funding, will I guess be the next challenge. What we have here is a great foundation document for decision making. Well done!
- 24. A Development Trust is necessary to ensure development within the village is in tune with the community. Governing traffic is a major concern in the Muckhart wider community, not solely on and around the 'High Street'. Traffic management for all speed limited areas is a significant problem currently the speed limits are not adhered to and a means of ensuring that speed limits are obeyed is necessary. Whether this is a combination of cameras, series of bumps (e.g. as in Gateside) where sufficient speed is never accrued so that vibration around bumps is not an issue the main factor is ensuring compliance.
- 25. I am extremely interested in a community-owned or shared ownership renewables project. I have wanted this for a long time and would have liked to participate in the Rumbling Bridge Hydro Scheme, had I had the financial means when it was first introduced.
- 26. Village desperately requires double yellow lines at corner of main road and Kirkhill going towards Mona's.
- 27. A development trust would facilitate the projects becoming a reality and tap into funding opportunities. Comments have already been made in relation to some of the actions. In terms of the others, Muckhart Golf Club is an important asset and there can only be benefits in making it more accessible for the community. The identification of business/office/storage units could support local businesses and start-ups and provide Development Trust income subject to a feasibility study. Muckhart Commonty is interesting but would need significant community buy in to explore this project and

funding to advance. Similarly, a civic space might be of interest in the longer term if the community backed the idea but I do not view this as a priority. Community Transport and Active Travel improvements are vital to the health of the community and residents, and have had support in the past. Transport is a project a DT could support and it would build on existing partnerships – with Glenfarg Community Transport for example. The Playpark upgrade, road appraisal and additional parking projects would also be priorities, with reuse/recycling and a community shop worth exploring too. Great to see this plan and the level of community engagement!

- 28. The Muckhart Horticultural Society would like to thank MCC for the time and effort they have put into producing these plans. We welcome the opportunity to comment on the plans from the perspective of the society's mission and aims. The committee are supportive of a Development Trust as it could bring funding and enable project delivery. However, we feel it is important to have identifiable aims and cross community membership. The committee are supportive of the reuse and upcycling initiative. If there was community support and a suitable site, then we would support a community compost. It might be easier to achieve if we had a community garden but this would be a bigger project and may not community support. We support the playpark improvement which could include an area for growing and planting and possible a compost area.
- 29. Neutral on Re-use project would like to understand the success of Dollar Repair Cafe. Development Trust This is a way to access funds for community projects without a pipeline of projects, it is not necessary. If it is created it must absolutely have representatives from across the age groups and our existing businesses in the village. It should not duplicate the great work that is already undertaken by so many volunteers in many clubs/societies. New initiatives like transport, community renewables and land ownership would be a good place for it to start e.g. Ballilesk Home Farm would be a great location for the village to establish a visitor centre, mountain bike access hub, trail running, adventure playground, small business units etc rather than let it be sold to a property developer.

The Hall Committee would like to thank MCC for the huge effort they have put in to producing our village development plan and the amount of time and resources they have committed to community engagement. We hope there are lots of views on the survey and some action can be taken going forward.

In relation to the community shop proposal, the car park may be an option, if we tried a Sunday Market type shop, but again if you can get to Kinross then you will get a bigger selection of goodies.
